1	The total number of sections of the school shall be restricted to 20. Further, the increase of section(s) shall be subject to specific approval of the Board based on the request of the school as per Affiliation Bye-Laws and subject to the availability of room(s) with an area greater than or equal to 500 sq ft.	
2	The School does not have a concrete boundary wall on all four (ref. RC video time 20:58, 41:23) sides of 6 feet height. Iron wires have been used as hurdles. Hence, the School shall construct/rectify it as per its SOP/Guidelines issued by the CBSE and submit the compliance in the SARAS portal within the next 3 months with videography.	
3	The ramp at the entrance (ref. RC video time 52:32, 1:08:44) has no safety handrails. Hence, the School shall construct/fix it as per its SOP/Guidelines issued by the CBSE and submit the compliance in the SARAS portal within the next 3 months with videography.	
4	Books in the Library are not sufficient. The Library should have sufficient age- appropriate books on all subjects in its stock. Books should include e-books, Fiction,	

	Non-fiction, Reference Books, Encyclopedias, Periodicals, Magazines, Journals, and Newspapers. Hence, the School is directed to ensure it is as per its SOP issued by the CBSE and submit the compliance in the SARAS portal within the next 3 months with videography.
5	The school shall replace benches in the library with chairs for students and staff within 3 months and submit compliance on SARAS with videography.
6	As it is not clear by the name that the HEAD OF SEXUAL HARASSMENT COMMITTEE is a male or female member. Hence, the School shall ensure it as per its SOP/Guidelines issued by the CBSE and submit the compliance in the SARAS portal within the next 3 months with documentary proof.
7	The school shall conduct training of its concerned teachers with CoE, Chandigarh within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
